VACCINATION and CASTRATION REQUIREMENTS

Fall Sales

November 4th 2020 Certified Calf Sale

November 18th 2020 Calves and Yearlings

IMPORTANT NOTICE TO BUYERS AND SELLERS

Consign to Wayne Telford or any other sale committee member by September 30th. Calves will not be accepted without completed application form, proof of vaccine purchase, signed info-link cards and a CCIA bar coded ear tag and all calves must meet the following

Entry Requirements

Castration-All male entries must be castrated by October 1st 2020 and properly healed by sale date. After September 1st only surgical or knife to remove testicle is eligible. It is strongly suggested that producers adopt the practice of castrating calves before three months of age. Please check all steers while processing in the fall.

If it is discovered after the animals are sold that they prove to be not castrated (as verified by a third party veterinarian) seller will pay the cost of having a veterinarian properly castrate the animal(s).

Dehorned-It is **preferred** that all calves be properly dehorned by no later than Oct 1st 2020 and properly healed by sale date. It is strongly recommended that calves be dehorned at birth or shortly thereafter by method of paste or electric dehorners.

Vaccinations – Killed Vaccination: All calves must be vaccinated in the neck area by Sept. 28th,2020 and have their booster shot no later than Oct. 14th ,2020 with a 5 way vaccine(IBR P13 BVD BRSV) plus HS. It is very important that when using a killed vaccine ,that the booster be given 2-4 weeks after the first shot .Consult your veterinarian for proper vaccination schedule.

Live Vaccinations: All calves must be vaccinated in the neck area by Oct. 14th,2020 with one shot of a live 5-way vaccine plus a shot of HS. (eg. Ultrabec 7)

Other Vaccinations: A Pasteur Elia Haemoltica vaccine (eg. Presponse or One-shot) must also be given to all calves, done with killed or live vaccine.

In summary , 3 injections must be given to calves done with live vaccine(Two if using Pyramid 5 and Presponse and HS). A photocopy of receipt of vaccine purchase is required along with signed info link cards.

Minimum Consignment Number: The minimum entry number is three(3). To improve the flow of the sale only 1 single per 10 head -- (Buyers request).

900 Head; Up to 900 head only will be accepted. Consign your calves early by contacting any sale committee member.
